Legislative update: JCT reports on repealing, replacing Affordable Care Act

The House Ways and Means Committee has scheduled for March 8, 2017, a markup of budget reconciliation recommendations to repeal and replace the Affordable Care Act. In advance of the markup, the Joint Committee on Taxation (JCT) today released its descriptions of the budget reconciliation legislative recommendations to:

- Repeal and replace certain health-related tax policy provisions
- Repeal the net investment income tax
- Repeal certain consumer taxes
- Repeal the deduction limit on remuneration from certain insurers
- Repeal of the tanning tax

The JCT also provided a revenue estimate.
