Cayman Islands: Issued Update to FATCA/CRS Deadlines

On 5 April 2023, the Department for International Tax Cooperation (DITC) of the Cayman Islands issued an Industry Advisory release containing updates related to Foreign Account Tax Compliance Act (FATCA) and Common Reporting Standard (CRS) deadlines.

The updates are as follows:

- The registration deadline for FATCA and CRS notification is 1 May 2023, as the statutory deadline of 30 April 2023 falls on a Sunday.
- The reporting deadline for FATCA and CRS, including reportable accounts and CRS filing declarations, is 31 July 2023.
- The deadline for submitting the CRS Compliance Form is 15 September 2023.
