# India - FRRO Registration, Visa Extension, Conversion, Go Digital

The Government of India has launched an online portal for registration, visa extension and other immigration-related services for foreign nationals visiting India. As of 12 February 2018, applicants for these services no longer have to visit a Foreigners Regional Registration Office (FRRO) in person.

# WHY THIS MATTERS

The e-FRRO portal is another milestone reform introduced by the Government of India having a direct impact on the foreign nationals in India, immigration professionals, and global mobility managers. The inbound employees as well as the family members accompanying them to India will not have to physically visit the FRRO. Beginning 12 February 2018, physical applications are no longer be accepted in specified jurisdictions and the foreigner has to apply through the e-FRRO portal following prescribed procedures.

# **Background**

The Government of India earlier had introduced the online Foreigner Registration Office (FRRO) to provide registration and visa extensions, etc. Foreign nationals could make appointments and submit documents online but needed to be physically present in an FRRO office for processing applications.

In line with its vision of "Digital India," the government has now introduced an e-FRRO portal<sup>1</sup> to provide a user friendly experience – faceless, cashless and paperless service to foreign nationals.

## e-FRRO Portal Features

Starting 12 February 2018, a mandatory visit to the local immigration office (FRRO) located in Bengaluru, Chennai,
Delhi and Mumbai is no longer necessary.

- The portal offers an online solution for application submission as well as for document upload for all visa and immigration-related services, including the Indian FRRO registration, visa extension or conversion, change of address/passport and exit permission.
- In emergency situations, one can still visit the local FRRO for services.

# **Steps Involved**

- A foreign national is required to create a user ID and password by registering on the online portal.
- After successful registration, the applicant can login into the portal and select the appropriate services required.
- The application form needs to be filled out online, and documentation and photographs should be uploaded.
- Necessary fees are paid online.
- The applicant will be notified of the status through email or SMS alerts.
- The foreign national can track the status of the application through the portal.
- The residency permit or certificate will be sent:
  - by post to the address provided in the online application; and
  - to the registered email address.

It can also be downloaded from the portal.

# **Noteworthy Point**

Applicants would be responsible under Indian laws, for any delay in fee payment or submission of documents, or to respond to requests for interviews, for example.

### **KPMG NOTE**

The introduction of the e-FRRO portal for foreign nationals can be seen as another breakthrough initiative of Government of India in line with its reforms of digital India and ease of doing business.

It is noteworthy that the portal does not specify any standard timelines for processing of the application. To avoid any delay, one should apply well in advance and upload documents following the prescribed guidelines.

This is a welcome step as the portal provides comprehensive list of services offered. Foreign nationals and their family members who were earlier required to be physically present at the FRRO office will be relieved of the hurdles of visiting the FRRO office. Digitisation of the entire process will also help the government in having better controls over its processes and providing ease to foreign nationals.
