# Romania - Digital Nomad Visa Could Soon Be Adopted

Romania is planning to adopt new legislative measures to enable more flexibility for remote working, by offering a socalled digital nomad visa.<sup>1</sup>

# WHY THIS MATTERS

This step is being taken in response to workplace issues tied to the coronavirus and the new reality of and dynamic changes to the labour market thanks to the widespread use of telecommunication technologies. The digital nomad visa will allow eligible individuals from outside the European Union (EU)/European Economic Area (EEA) to work more flexibly and with fewer constraints in Romania for a fixed period of time "outside" the usual rules that apply if someone were to come and work in Romania.

# **More Details**

The new draft law aims to modify Emergency Ordinance no. 194 /2002 on regulations for foreigners in Romania through the introduction of a specific type of visa for digital nomads who are defined as third-country nationals (i.e., non-EU/EEA nationals) working remotely from Romania for an international employer, or for a company they have registered outside Romania, while living in and exploring the country.

The digital nomad visa may be issued if certain specific conditions are observed, including: proof of being an employee, or an owner of a company registered outside of Romania, proof that for six months before applying for the visa, and for the period during which the visa is being applied for, the digital nomad has had and will have income amounting to at least the equivalent of the average national income, proof of health insurance for the period for which the visa will be issued, as well as further requirements.
