If you go the external audit route, you'll do the Auditing and Assurance elective.



#### **Gain practical experience**

The CA Advisory programme requires candidates to gain practical experience by rotating through various Advisory business units. This will be done throughout the three-year period until you've been exposed to all the prescribed competencies. If you have not met the required competencies within this period, the contract may be extended or cancelled.
