## Bahrain

### Bahrain Corporate Income Tax (CIT)

Multiple public announcements have confirmed that Bahrain's 2025–2026 fiscal budget includes a proposal to introduce a broad-based CIT, a position reiterated by the International Monetary Fund (IMF) in November 2025. On 21 December 2025, the Bahrain executive and legislative authorities held a joint meeting to discuss proposed initiatives to develop public finances with one of the key measures being the taxation of business profits exceeding a specified threshold.

Based on the above, we expect Bahrain to soon introduce a standard CIT regime similar to other GCC countries. The regime may take effect for fiscal years beginning 1 January 2026 (or 1 January 2027) with the law and executive regulations expected to be issued in the next few months.
