STAY PERIOD EXTENSION ORDER

- [1] **ON READING** the Monitor's *Application for an Extension of the Stay Period* (the "**Application**"), the sworn statement and the exhibits in support thereof, dated April 27, 2026;
- [2] **CONSIDERING** the notification of the Application;
- [3] **CONSIDERING** the submissions of the Monitor's attorneys and the testimony of the Monitor's representative;

- [4] **CONSIDERING** the Monitor and Monitor's counsel's invoices for professional fees and disbursements filed as Exhibit R-2, *under seal*;

FOR THESE REASONS, the Court:

- [5] **GRANTS** the Application;

NOTIFICATION

- [6] **ORDERS** that any prior delay for the presentation of the Application is hereby abridged and validated so that the Application is properly returnable today and hereby dispenses with further service thereof.

- [7] **DECLARES** that capitalized terms in this order shall have the meaning ascribed to them in the Amended and Restated Initial Order dated December 20, 2023 (the "ARIO");

STAY OF PROCEEDINGS

- [8] **EXTENDS** the Stay of Proceedings to **September 18, 2026**;

- [9] **ORDERS** that paragraph 7 of the ARIO read as follows:

7. **ORDERS** that, until and including **September 18, 2026**, or such later date as the Court may order (the "Stay Period"), no proceeding or enforcement process in any court or tribunal (each, a "Proceeding") shall be commenced or continued against or in respect of the Debtor, or affecting the Debtor's business operations and activities (the "Business") or the Property (as defined below), including as provided in paragraph 10 below except with leave of this Court. Any and all Proceedings currently under way against or in respect of the Debtor or affecting the Business or the Property are hereby stayed and suspended pending further order of this Court, the whole subject to subsection 11.1 CCAA.

- [10] **ORDERS AND DECLARES** that the Monitor is hereby authorized to pay its professional fees and disbursements, as well as those of its counsel, in the amount of \$57,139.00 plus applicable taxes (as per Exhibit **R-2**), as of April 24, 2026, from the funds currently held in trust by the Monitor for the Debtor;

- [11] **ORDERS** that the Monitor and Monitor's counsel's invoices for professional fees and disbursements filed in support of this Application (Exhibit **R-2**) be kept confidential and *under seal* until further order of this Court;

- [12] **ORDERS** the provisional execution of this Order notwithstanding appeal;

[13] **THE WHOLE** without costs.
