**Juan Sebastián Lombana Sierra**, of legal age, domiciled in the city of Bogotá, identified with Citizenship ID No. 11,233,717 and Professional License No. 161,893 issued by the Superior Council of the Judiciary, acting in his capacity as judicial counsel for **MACQUARIE BANK LTD.** (hereinafter, "Macquarie"), hereby respectfully informs the Office that Macquarie's counsel in the reorganization proceeding of Canacol Energy Ltd. and its subsidiaries before the Court of King's Bench of Alberta, Judicial Centre of Calgary, Canada, conducted under the Companies' Creditors Arrangement Act (CCAA), has filed a memorandum seeking authorization to pursue an appeal before the Alberta Court of Appeal. Said appeal concerns the order addressing matters related to debtor-in-possession financing (DIP Financing) issued on December 11, 2025.

In this regard, I hereby submit to the Delegated Superintendency an informal copy of the referenced brief, together with its unofficial translation, for purposes of providing prompt notice within this proceeding, particularly given that this information should have been provided by the Monitor pursuant to its duty of disclosure, insofar as it has, or may have, repercussions for the proceeding currently before the Delegated Superintendency.
