AND it appearing to the Court that the following acts of bankruptcy have been committed:


- a. Counterpoint Interiors Inc. has ceased to meet their liabilities generally as they become due.

THIS COURT ORDERS that:



3. The Court further orders that the costs of the applicant be paid out of the estate of the bankrupt on taxation of the estate.
