



Data Privacy Assessment

A way to measure compliance with data protection obligations independently or as a part of internal audit



As the revised Swiss Federal Act on Data Protection (FADP) entered into force in September 2023, data protection compliance became more important than ever. The proper implementation and management of a data privacy governance is crucial in order to manage operational and reputational risks to avoid potentially substantial fines for non-compliant practices. Ensuring data privacy compliance is essential to avoid reputational and financial risks. Non-compliance could result in reputational damage through press reports and substantial fines, – up to CHF 250,000 (revFADP) for responsible employees and up to EUR 20 million or 4% of the global turnover for the entity (GDPR).
