What is the purpose and on what legal basis we are processing personal data, what is the retention period and how we collect your personal data and what is consequence in case of not providing personal data and who is recipient of personal data?

The above mentioned information you can find below classified according to categories of Data Subjects.

(1) Employees of contractual partners

- Your personal data are processed for the **purpose** of providing service by one of KPMG member firms based on contract with your employer (i.e. you as a Data Subject are not a party to a contract to which the processing activity relates);
- The **legal basis** of these processing activities is the legitimate interest of KPMG member firms in proper provision of the services.
- Personal data are collected:
 - **Directly from you**, e.g. from business card or meetings, identification in contract, or other documents which you give us personally or send us via email or other means of electronic communication;
 - From third party, which are in employment or other similar relation with your employer.
- The **retention period** of your personal data is set out by relevant legislation (mainly Act on archives and registries, Act on accounting) and Registry plan. Your personal data will not be stored longer than it is necessary. Retention period of your personal data is o reach above mentioned purpose is 10 years.
- Providing personal data to KPMG member firms for the mentioned purposes may in some cases be a
 contractual requirement or requirement that is necessary for the conclusion of a contract. Data subject
 is not obliged to provide the personal data to the Controller. As a result of their non-disclosure it
 may not be possible to provide the services to your employer or it will be more difficult to provide
 them.
- KPMG member firms engaged the following Processors for the data processing for this processing purpose: DocuSign, Inc. (USA); KPMG Member Firms (provision of supporting services).
- Provided that this is necessary to protect our interest, exercising our rights KPMG member firms **provide** your personal data in proportional extent to **following recipient:**
 - Relevant Public Authorities (e.g. Tax office, social security authorities);
 - Law enforcement authorities;
 - competent courts.

(2) Contractual partners – natural persons



- Your personal data are processed for the purpose of providing services by one of the KPMG member firms based on contract concluded with you.
- The legal basis of these processing activities is the fulfilment of a contract to which you are a party, or to make pre-contractual arrangements at your request..
- Personal data are collected:
 - Directly from you, e.g. from communication or a meeting, from identification in a contract or other documents give us or send us personally or via email or via other means of electronic communication or from your pre-contractual relationship with KPMG member firms;
 - from public and non-public registries, mainly from commercial register and trade register;
- the **retention period** of your personal data is set out by relevant legislation (mainly Act on archives and registries, Act on accounting) and Registry plan. Your personal data will not be stored longer than necessary. Retention period of your personal data to achieve listed purpose is 10 years. In case you were, as our contractual partner, included in the internal database of employees of KPMG (SK-DL ALL Staff) your personal data will be stored according to retention periods set for our employees.
- Providing personal data to KPMG member firms for the mentioned purposes may in some cases be a contractual requirement or requirement that is necessary for the conclusion of a contract. The data subject is obliged to provide personal data to the controller. As a result of their non-disclosure it may not be possible to provide the services to your employer or it will be more difficult to provide them.
- Provided that this is necessary to protect our interest, exercising our rights KPMG member firms provide your personal data in proportional extent to following recipient:
 - Relevant Public Authorities (e.g. Tax office, social security authorities);
 - Law enforcement authorities;
 - competent courts.

(3) Internal quality and risk management

- We also process your personal data for the purpose of performing internal controls, the subject of which is internal risk assessment and quality assurance and compliance with professional standards in the provision of services;

Where do we process your personal data?

We are processing your personal data for here mentioned purposes mostly in the European Union. However, within processing operations listed in this Notice, personal data are occasionally also transferred (except processing data within EU) to a third country. Cross-border transfer takes place in connection with internal controls, the subject of which is internal risk assessment and quality assurance and compliance

with professional standards in the provision of services. Appropriate safeguards for transfer of personal data to third countries are ensured in the form of standard data protection clauses according Article 46 of GDPR.

Which categories of personal data are we processing?

We are processing common categories of personal data (e.g. name, surname, email, job, employer and other).

How do we process your personal data?

Processing of your personal data can be manual or automated, when your personal data is processed in our information systems or information systems of our Processors.

Your personal data are processed only by selected employees of KPMG member firms. In this relation we take care that only trained and selected employees have access to your personal data and they fulfil obligations of confidentiality in relation to all the data (personal or other) that they learned during the performance of their work.

Personal data are not subject to automated individual decision-making, including profiling.

What are your rights in the data protection area?

Under relevant data protection legislation (unless generally binding legal regulations do not stipulate otherwise), you have a right to:

- information about processing of your personal data;
- **access** to your personal data, including the right to obtain copy of your personal data processed by us;
- **portability of the data** which you have provided to us (in a structured, commonly used and machinereadable format) and which we are processing based on your consent by automated means; you have the right to transmit those data to another Controller (if such transfer is technically feasible);
- **rectification** of your wrong, inaccurate or outdated personal data. When accuracy of your data is questionable you can request **restriction** of its processing until we will be able to check its accuracy;
- **restriction of processing of** personal data under condition that the personal data will be stored but not processed;
- **erasure ('right to be forgotten')** of your personal data in cases specifically allowed by data protection legislation, e.g.:
 - your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
 - you would object to processing of personal data processed on the basis of our legitimate interest and we would not demonstrate necessary legitimate reasons for our processing that would outweigh your interests and rights and freedoms;

- any time contact our Data Protection Officer by using any communication means mentioned in this document. You can also contact the Data Protection Officer in case you think that we breach your rights under data protection legislation;
- when you believe that in relation to processing of your personal data, your rights were breached or that you were directly affected by such breach, you have a right to lodge a complaint with supervisory authority (Úrad na ochranu osobných údajov Slovenskej adress Hraničná 4826/12, 820 07 Bratislava - Ružinov, tel. number: +421 /2/ 3231 3214; mail: statny.dozor@pdp.gov.sk, https://dataprotection.gov.sk/uoou/) or to a relevant court.

What is your right to object?

You have right to object any time to the processing of your personal data, which is performed on the basis of our legitimate interest. Objection could be lodged to our Data Protection Officer personally or by using any of our listed contacts.

When we consider that our legitimate interest prevails over your interest or rights and freedoms, we can continue to process your personal data. When your objection will be appropriate, we stop processing your personal data for this purpose.

Joint controllers

The companies KPMG Slovensko spol. s r.o., KPMG Slovensko Advisory, k.s., KPMG Legal s.r.o. and KPMG Valuation s.r.o. (for the purposes of this chapter, jointly referred also as "KPMG in Slovakia") are in the position of joint controllers in the processing of your personal data carried out in accordance with this Data Protection Notice.

In order to define the terms of the joint processing of personal data, the companies of KPMG in Slovakia have concluded a Joint Controllership Agreement (hereinafter referred to as "Agreement"). Pursuant to the Agreement, company KPMG Advisory will provide the respective data subject with the essential details of the Agreement in accordance with Article 26 (2) of GDPR, based on data subject's prior request.

Based on the Agreement, the exercise of your rights will be carried out by the company KPMG Slovensko Advisory, k.s., as a designated contact point for data subjects. As a data subject, you can exercise your rights at any of the KPMG in Slovakia companies, through the contact channels listed in the section " How can I contact the Data Protection Officer?" of this Information on the processing of personal data, or in writing at the address of the KPMG Slovakia companies listed in the section " Who is the Controller?" of this Data Protection Notice.

How often do we update this notice?

This information is periodically reviewed and could be changed from time to time (in order to comply with new legislation and to reflect our current privacy practices). Updated versions will be available on our web
