We would like to inform you how and for what purpose we process, as a controller, your personal data and we want to point out your rights in the personal data protection area.

## How can you contact the Data Protection Officer?

# Who might be a data subject?

Data subjects, whose personal data we are processing under this Data Protection Notice are in particular the following categories of persons:

- employees and former employees of KPMG member firms;
- business partners and their employees;
- current, former and potential clients or their employees...



What is the purpose and legal basis of processing of your personal data, what is the retention period; how we collect your personal data; what is the consequence in case of not providing the personal data; who is the recipient of personal data?

The information listed below is broken down by the categories of persons concerned, or by the type of the processing activity.

### (1) Participants in external events

- We process your personal data for the purpose of organizing and realization of an external event organized by KPMG member firms and informing participants and the public about the planed event;
- The legal basis for this processing activities is the legitimate interest of KPMG member firms in building and developing relationships with the Data Subjects.
- We collect personal data:
  - directly from you, for example from a business card, communication or negotiation, identification in the contract, or other documents you hand over to us personally or send us by email or other electronic forms of communication;
  - from **third parties** who are in a contractual, employment or similar relationship with you.
- We keep your personal data for the duration of our legitimate interest and in accordance with applicable legislation (in particular Act No. 395/2002 Coll., on Archives and Registries and on amendments of certain acts as amended) and our Registry Plan. Retention period of your personal data in order to achieve the above purpose is 1 year following the year in which the event took place. We will not keep your personal data longer then it is necessary.
- The Data Subject is not required to provide the personal data to the Controller. As a result of their non-disclosure, in most cases it may not be possible for Data Subject to participate at the event organized by KPMG member firms (depending on whether non-disclosure of personal data by the Data Subject prevents KPMG member firms in proper realization of the event).
  - KPMG member firms use for this purpose of processing following Processor: Survey Monkey Europe UC, with its registered seat: Shelbourne Rd, Ballsbridge, Ireland; WebSupport s.r.o., with registered seat at Karadžičova 12, 821 08 Bratislava, registered in the Commercial register maintained by Municipal Court Bratislava III, section: Sro, insert no. 63270/B, identification number: 36 421 928 and event agencies.
  - Provided that this is necessary to protect the interests of the Controller and I order to exercise of his rights, KPMG member firms may provide your personal data in proportional extent to the following recipients:
  - companies where event takes place,
  - shipping companies,
  - companies providing webdevelopment services under confidentialility condition,
  - law enforcement authorities,
  - competent courts.

#### (2) Subjects of External communication

We process your personal data for the purpose of informing the public about the various facts and events that help promote services of KPMG member firms and develop KPMG brand.

- **The legal basis** for the processing activity is:
  - · KPMG member firms' legitimate interest to promote services of KPMG member firms' and develop KPMG brand and to build and develop relationships with Data Subjects; and
  - in relevant cases, the **consent** of the Data Subject;
- We collect personal data:
  - directly from you, for example from a business card, communication or negotiation, identification in the contract, or other documents you hand over to us personally or send us by email or other electronic forms of communication or obtained from you during your participation in events organized by KPMG member firms or in the events where we take part in their realization;
  - from third parties who are in a contractual, employment or similar relationship with you.
- We keep your personal data for the duration of our legitimate interest and in accordance with applicable legislation (in particular Act No. 395/2002 Coll., on Archives and Registries and on amendments of certain acts as amended) and our Registry Plan. Retention period of your personal data in order to achieve the above purpose is 50 years. We will not keep your personal data longer then it is necessary.
- In case your consent is the legal basis for the processing of personal data, we keep Data Subject's personal data for the duration of given consent, but no longer than necessary to achieve the above-mentioned purpose of data processing.
- The Data Subject is not required to provide the personal data to the Controller. As a result of their non-disclosure, the personal data of the Data Subject will not be processed in the external communications of KPMG member firms.
- KPMG Slovakia engaged the following Processors for the data processing for this processing purpose: WebSupport s.r.o., with registered seat at Karadžičova 12, 821 08 Bratislava, registered in the Commercial register maintained by Municipal Court Bratislava III, section: Sro, insert no. 63270/B, identification number: 36 421 928.
- Provided that this is necessary to protect the interests of the Controller and the exercise of his rights, KPMG member firms may provide your personal data in proportional extent to the following recipients:
  - companies providing webdevelopment services under confidentialility condition,
  - social media providers (e. g. LinkedIn, Facebook, Instagram, YouTube),
  - other providers of services necessary for the proper performance of the purpose,
  - law enforcement authorities,
  - competent courts.

# Where do we process your personal data?

We process your personal data for the above purposes only in the European Union. We do not transfer personal data to third countries or international organization.

#### What categories of personal data do we process?

The subject of our processing of personal data are a common categories of personal data (e. g. name, surname, email address, work position, employer and other personal information). The processing

## How do we process your personal data?

Processing of your personal data can be manual or automated, where your personal data is processed in our information systems or information systems of our Processors.

Your personal data are processed only by selected employees of KPMG member firms. In this relation we take care that only trained and selected employees have access to your personal data and they fulfil obligations of confidentiality in relation to all the data (personal or other) that they learned during the performance of their work.

Personal data are not subject to automated individual decision-making, including profiling.

# What are your rights in the data protection area?

Under relevant data protection legislation (unless generally binding legal regulations do not stipulate otherwise), you have a **right to**:

- information about processing of your personal data;
- **access** to your personal data, including the right to obtain copy of your personal data processed by us:
- **portability of the data** which you have provided to us (in a structured, commonly used and machinereadable format) and which we are processing based on your consent by automated means; you have the right to transmit those data to another Controller (if such transfer is technically feasible);
- **rectification** of your wrong, inaccurate or outdated personal data. When accuracy of your data is questionable you can request **restriction** of its processing until we will be able to check its accuracy;
- **restriction of processing of** personal data under condition that the personal data will be stored but not processed;
- **erasure** (**'right to be forgotten')** of your personal data in cases specifically allowed by data protection legislation, e.g.:
  - your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
  - you would object to processing of personal data processed on the basis of our legitimate interest and we would not demonstrate necessary legitimate reasons for our processing that would outweigh your interests and rights and freedoms;
  - you withdraw your consent;
- if you provided a **consent** with processing of your personal data, you can **withdraw it at any time** by contacting our Data Protection Officer personally our by using any communication mean listed in this

document; the consent withdrawal consent does not affect the lawfulness of the processing of personal data prior to the withdrawal;

- any time contact our Data Protection Officer by using any communication means mentioned in this
  document. You can also contact the Data Protection Officer in case you think that we breach your
  rights under data protection legislation;
- when you believe that in relation to processing of your personal data, your rights were breached or that you were directly affected by such breach, you have a right to lodge a complaint with a supervisory authority (Úrad na ochranu osobných údajov Slovenskej republiky, adress Hraničná 4826/12, 820 07 Bratislava Ružinov, tel. number: +421 /2/ 3231 3214; mail: <a href="mailto:statny.dozor@pdp.gov.sk">statny.dozor@pdp.gov.sk</a>, <a href="https://dataprotection.gov.sk/uoou/">https://dataprotection.gov.sk/uoou/</a>) or to a relevant court.

## What is your right to object about?

You have **right to object** any time to the processing of your personal data, which is performed on the basis of our legitimate interest. Objection could be lodged to our Data Protection Officer personally or by using any of our listed contacts.

When we consider that our legitimate interest prevails over your interest or rights and freedoms, we can continue to process your personal data. When your objection will be appropriate, we stop processing your personal data for this purpose.

#### Joint controllers

The companies KPMG Slovensko spol. s r.o., KPMG Slovensko Advisory, k.s., KPMG Legal s.r.o. and KPMG Valuation s.r.o. (for the purposes of this chapter, jointly referred also as "KPMG in Slovakia") are in the position of joint controllers in the processing of your personal data carried out in accordance with this Data Protection Notice.

In order to define the terms of the joint processing of personal data, the companies of KPMG in Slovakia have concluded a Joint Controllership Agreement (hereinafter referred to as "Agreement"). Pursuant to the Agreement, company KPMG Advisory will provide the respective data subject with the essential details of the Agreement in accordance with Article 26 (2) of GDPR, based on data subject's prior request.

Based on the Agreement, the exercise of your rights will be carried out by the company KPMG Slovensko Advisory, k.s., as a designated contact point for data subjects. As a data subject, you can exercise your rights at any of the KPMG in Slovakia companies, through the contact channels listed in the section " How can I contact the Data Protection Officer?" of this Information on the processing of personal data, or in writing at the address of the KPMG Slovakia companies listed in the section " Who is the Controller?" of this Data Protection Notice.

#### How often do we update this notice?

This information is periodically reviewed and could be changed from time to time (in order to comply with new legislation and to reflect our current privacy practices). Updated versions will be available on our web site.
