any other data subjects whose personal date may be included in accounting or registry records.

What is the purpose and legal basis of processing of your personal data, what is the retention period; how we collect your personal data; what is the consequence in case of not providing the personal data; who is the recipient of personal data?

Your personal data are processed for the **purpose** of maintenance of accounting and management of registry records of KPMG member firms.

The legal basis of the aforementioned processing operations is the fulfilment of our statutory obligations imposed by the Act No. 395/2002 Coll. on archives and registers as amended, Act no. 431/2002 Coll. on accounting, as amended, and any other legislation which implement the aforementioned legislation or impose duties in the area of accounting and registry administration.

Personal data are collected:

- directly from you, for instance from communication or negotiation, from contract identification, or from other documents you submit to us personally or by e-mail or other electronic forms of communication or from the data you provide to us when you participate in training organised by one of KPMG's entities or in the context of employment relationship, contractual or pre-contractual relationships that you or your employer have with any KPMG entity;
- **From public and non-public registers and records**, particularly from the commercial register, the trade register, the website of your employer/business; and exceptionally
- From the third parties who are in a contractual, employment or similar relationship with you.

We generally retain your personal data **for the period** of time prescribed by law (especially the Archives and Registry Act and Act on Accounting) and our registry plan. We will not store your data longer than necessary.

Personal data which is the subject of accounting or registry records is originally acquired by the controller for various purposes (e.g. performing tasks within the scope of personal and wage agenda, providing advisory services to clients). Information on whether the provision of personal data is a legal or contractual requirement or a requirement that is required to conclude a contract, whether the data subject is required to provide personal data, and the possible consequences if refused to provide such data are therefore described, in more detail, in the corresponding information on the processing of personal data which can be found on the KPMG web site at https://home.kpmg/sk/sk/home/misc/privacy.html

KPMG authorized the following Processor to process the personal data for this purpose: F.M. - law enforcement authorities; and
- competent courts.

Where do we process your personal data?

We are processing your personal data for listed purposes only in the European Union. We do not transfer personal data to third countries or international organization.

Which categories of personal data do we process?

The subject of our personal data processing are mainly regular personal data categories (e.g. name, surname, email address, job position, employer, and other data which can be stated in accounting or registry records)

However, the registry records may also contain a specific personal data category such as information relating to health condition of a KPMG employee which the controller originally processed within his payroll and human resources/personal agenda.

How do we process your personal data?

Processing of your personal data can be manual or automated, when your personal data is processed in our information systems or information systems of our Processors.

Your personal data are processed only by selected employees of KPMG member firms. In this relation we take care that only trained and selected employees have access to your personal data and they fulfil obligations of confidentiality in relation to all the data (personal or other) that they learned during the performance of their work.

Personal data are not subject to automated individual decision-making, including profiling.

What are your rights in the data protection area?

Under relevant data protection legislation (unless generally binding legal regulations do not stipulate otherwise), you have a right to:

- information about processing of your personal data;
- access to your personal data, including the right to obtain copy of your personal data processed by us;
- portability of the data which you have provided to us (in a structured, commonly used and machinereadable format) and which we are processing based on your consent by automated means; you have the right to transmit those data to another Controller (if such transfer is technically feasible);
- rectification of your wrong, inaccurate or outdated personal data. When accuracy of your data is questionable you can request **restriction** of its processing until we will be able to check its accuracy;
- restriction of processing of personal data under condition that the personal data will be stored but not processed;
- erasure ('right to be forgotten') of your personal data in cases specifically allowed by data protection legislation, e.g.:

- your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
- you would object to processing of personal data processed on the basis of our legitimate interest and we would not demonstrate necessary legitimate reasons for our processing that would outweigh your interests and rights and freedoms;
- any time contact our Data Protection Officer by using any communication means mentioned in this
 document. You can also contact the Data Protection Officer in case you think that we breach your
 rights under data protection legislation;
- when you believe that in relation to processing of your personal data, your rights were breached or that you were directly affected by such breach, you have a right to lodge a complaint with a supervisory authority (Úrad na ochranu osobných údajov Slovenskej republiky, address Hraničná 4826/12, 820 07 Bratislava Ružinov, tel. number: +421 /2/ 3231 3214; mail: statny.dozor@pdp.gov.sk, https://dataprotection.gov.sk/uoou/) or to a relevant court.

What is it about your right to object?

You have right to object any time to the processing of your personal data, which is performed on the basis of our legitimate interest. Objection could be lodged to our Data Protection Officer personally or by using any of our listed contacts.

When we consider that our legitimate interest prevails over your interest or rights and freedoms, we can continue to process your personal data. When your objection will be appropriate, we stop processing your personal data for this purpose.

Joint controllers

The companies KPMG Slovensko spol. s r.o., KPMG Slovensko Advisory, k.s., KPMG Legal s.r.o. and KPMG Valuation s.r.o. (for the purposes of this chapter, jointly referred also as "KPMG in Slovakia") are in the position of joint controllers in the processing of your personal data carried out in accordance with this Data Protection Notice.

In order to define the terms of the joint processing of personal data, the companies of KPMG in Slovakia have concluded a Joint Controllership Agreement (hereinafter referred to as "Agreement"). Pursuant to the Agreement, company KPMG Advisory will provide the respective data subject with the essential details of the Agreement in accordance with Article 26 (2) of GDPR, based on data subject's prior request.

Based on the Agreement, the exercise of your rights will be carried out by the company KPMG Slovensko Advisory, k.s., as a designated contact point for data subjects. As a data subject, you can exercise your rights at any of the KPMG in Slovakia companies, through the contact channels listed in the section " How can I contact the Data Protection Officer?" of this Information on the processing of personal data, or in writing at the address of the KPMG Slovakia companies listed in the section " Who is the Controller?" of this Data Protection Notice.
