## Classroom based training

## Online Modules

- **Bite size online modules:** To provide core awareness training focused on business activities and the application of the CASS rules. Training will be delivered as four 15 – 20 mins bite-sized online learning modules.
- **Online assessments:** To evaluate and measure learners' knowledge and understanding against the objectives set for the programme for the main audience groups: CASS Oversight & Middle Office, Compliance and Operations teams.
