

To pilot Copilot, KPMG Australia built a proof of concept of an enterprise Comply AI platform using Copilot as one of the primary AI technologies from Microsoft. This initiative aimed to transform employee workflows by accelerating data discovery, automating administrative tasks, and enhancing coworker and client collaboration. This section highlights some of the ways Copilot and the Comply AI platform have redefined productivity and client engagement across several dimensions for KPMG subject matter specialists and contributed to the launch of the KPMG value realization framework for Copilot.
